## a message from our director

The Child Advocacy Center (CAC) approach to helping child victims of abuse and their families is built on collaboration. At the heart of the Granite State Children's Alliance (GSCA), the chapter organization in New Hampshire, is a network of eleven Child Advocacy Centers with a common mission to provide all victims of child abuse with a neutral environment where **justice, equity, healing, and prevention** are fostered through consistent, high quality and sustaining collaboration of community partners. **We know it takes all of us working together to help children heal, survive, and thrive.** 

Never has the need for collaboration been more necessary than when the COVID-19 global pandemic hit in early 2020. Here in NH and around the nation CACs rallied together with their multidisciplinary teams to ensure essential services would stay the course to support child victims and their caregivers.

It is an unfortunate reality that instances of child abuse increase during times of extreme stress, therefore, during the pandemic, NH CAC doors remained open as essential services. As our communities opened back up and some restrictions were lifted, CACs experienced a 66% increase in referrals for forensic interviews from April through June 2020. There was also a 28% increase in interviews for June 2020 as compared to June 2019. With so many schools moving to online instruction or managing a hybrid model, teachers and other child facing professionals just didn't have the same vantage point to evaluate their students' well-being. This prompted GSCA to prioritize resources and elevate awareness of this concern. We utilized our education and outreach program, KNOW & TELL™, to inform NH adults of their moral responsibility and mandated duty to report suspicions of abuse and neglect to DCYF or local law enforcement.

On the following pages you will see us as we were in 2020, unprecedented times for all of us. On every page you will see that we persevere because our work makes a difference. We work together because that is what children and caregivers need from us. Thanks to your generosity and compassion we stay committed to making New Hampshire a better and safer place for kids.

Turn the page to see the impact the NH CACs have, as a collective, in helping children and their caregivers heal in a comprehensive, seamless way so no future is out of reach.

### what We do and Why

### why: our motivation

Child Advocacy Center team members remain dedicated to the tireless fight to ensure that children and their caregivers have a victim-centered experience in a safe and responsive place to move beyond their trauma to Heal, Survive and Thrive.

### how: what we do

Child Advocacy Centers partner with multiple public, private, state, county and local organizations to provide a collaborative, coordinated systematic response to child abuse investigations and subsequent supports for child victims and their caregivers. Our CACs are intentionally designed to be child/family friendly, trauma informed, victim centered, neutral settings for joint investigations and forensic interviews of child victims of crime involving sexual abuse, felony level physical abuse, and child witnesses to violence such as a homicide or a serious domestic assault.

### impact: positive outcomes for kids

We seek justice for child victims while supporting children and their caregivers on a sustainable path to healing.


## improving outcomes for children


In 2020, in the midst of a global pandemic, all 11 of New Hampshire's Child Advocacy Centers remained open to serve the needs of child victims of abuse and their caregivers. During this year CACs in New Hampshire provided forensic interview services to 1,640 children.

### 1,640 child victims provided a forensic interview

## 1,071 (65%) children referred to trauma informed mental health services

CAC staff and partners had 2,830 follow up contacts with caregivers to ensure they were accessing the services they needed for their children and themselves. 554 (33%) children referred to specialized medical providers trained to assess and treat children who are victims of physical and sexual abuse.

## initiatives / campaigns for change

### Youth with Problematic Sexualized Behavior (YPSB)

The Office of Juvenile Justice and Delinquency Prevention (OJJDP) reports Youth with Problematic Sexualized Behavior (YPSB) commit more than one-third (35.6%) of sexual offenses committed against minors. Reports from a NH assessment of the most significant areas of concern for Child Advocacy Centers statewide confirm an inconsistent response to YPSB. These cases are an area of great concern statewide for many key stakeholders.

In 2020, the NH Attorney General's Office – Children's Justice Act (CJA) provided grant funding for Dr. Wendy Walsh from UNH Crimes Against Children Research Center to collaborate with the Granite State Children's Alliance to explore YPSB cases in NH. This project aims to guide all multidisciplinary team members and the NH Attorney General's Task Force in developing best practice policies and procedures for the assessment, investigation, prosecution, and treatment for children involved in YPSB cases. This project is underway; all research will be completed by June 2021 and published near the end of year.

## Statewide data collected in 2019 indicates that **between 25-30%**

of cases at New Hampshire CACs involved child victims of sexual offenses committed by youth with problematic sexualized behavior (YPSB).

### Helping Ensure Appropriate Response to Trauma Program (HEART)

Child Advocacy Centers (CACs) in NH served over 1,600 children for interviews related to physical abuse, sexual abuse, neglect, as a witness to a violent crime, or some other Adverse Childhood Experiences (ACEs) in 2020.

The majority of children seen at NH CACs are of school age. Often educational staff, teachers, guidance, or school administrators are not aware that a student has experienced some trauma or adverse experience. Research indicates that an appropriate response and early intervention can help to mitigate the long-term effects of childhood trauma.

The HEART program, developed by GSCA in September of 2019, forms collaboration between school districts and their local CAC. The HEART program provides education to school wellness staff on the multidisciplinary approach at CACs, Adverse Childhood Experiences (ACEs), and the potential negative effects childhood trauma can have on a child's ability to learn. The program allows CACs (with parental permission) to inform appropriate school personnel when a child has been seen at a CAC. This communication allows school personnel to respond to any potential negative trauma responses that create behavioral or educational challenges in an appropriate, trauma-informed way.

The HEART program was a feature topic for the Northeast Regional CAC podcast and was chosen as a presentation topic for the National Children's Alliance annual symposium. HEART is currently in five school districts and expansion of the HEART program continues in New Hampshire.

### Beards for Bucks - Razorless for a Reason Fundraising Campaign for Child Advocacy Centers in New Hampshire

Five years ago, a Detective with the Manchester PD felt uneasy about the lack of security for the CAC staff members at the Hillsborough North CAC and decided to find a way to help raise funds for a new security



system. Beards for Bucks — Razorless for a Reason was born!

Beards for Bucks is a statewide fundraising effort where local police officers grow beards to raise awareness of the work done at CACs and encourage giving. This initiative helps raise funds to support the services and programs offered by community Child Advocacy Center in NH! Child Advocacy Centers do not charge for the essential service provided to law enforcement and other community stakeholders. In the five years since the first Beards for Bucks fundraiser, the campaign has grown across the state in more ways than one. 2020 presented a unique challenge for Beards for Bucks. As we organized and prepared during the COVID-19 pandemic, we had hopeful but limited expectations that we would reach our \$200,000 statewide goal for Child Advocacy Centers across New Hampshire. We are still pinching ourselves from the success of this year. We have to thank each and every



police department who participated, those who donated to their efforts and the communities that support our work with child victims of crime.

### **KNOW & TELL<sup>™</sup> for Healthcare Providers**

KNOW & TELL<sup>™</sup> is an educational program developed by the GSCA and many statewide stakeholders to educate all adults to KNOW the signs of child abuse and neglect and how to TELL responsible authorities when child maltreatment is suspected. Over the last 3 years, GSCA has educated over 8,000 adults in schools and youth serving organizations. Through this work with Dr. Wendy Gladstone (retired child abuse pediatrician) and Dr. Resmiye Oral (Child Advocacy and Protection Program (CAPP) Director at Dartmouth-Hitchcock) and our KNOW & TELL<sup>™</sup> Advisory Board it became clear that there was a need to expand KNOW & TELL<sup>™</sup>'s reach to those working in healthcare fields. Recognition and response to child maltreatment in the healthcare setting can be especially challenging and often times there is a lack of education and proper training for providers. With Dr. Gladstone and Dr. Oral's guidance, development on the KNOW & TELL<sup>™</sup> for Healthcare Providers program began in October 2019 and continues through the pilot phase through June 2021.



### **Expanded Service Model CAC in NH**

### **On-Site Specialized Medical Services**

A 2015 study regarding access to specialized medical services for child victims of abuse showed a significant lack of local access to this service. The lack of accessibility created a significant barrier for child abuse victims to

receive the specialized medical evaluations they needed to begin the healing process. Increasing access to this much needed service became a priority. To address this problem, the Greater Lakes CAC opened a Trauma Informed Health Services Suite in November of 2019. offering specialized medical evaluations on-site

The on-site clinical program is a collaboration between the Granite State Children's Alliance and the New Hampshire

Coalition Against Domestic and Sexual Violence. This partnership provides funding and medical practitioners through the Sexual Assault Nurse Examiner (S.A.N.E.) program. Under the supervision of certified child abuse pediatric specialist Dr. Karyn Patno, Janet Carroll, RN and Jennifer Pierce-Weeks RN spearheaded the development of the clinical program. Together with Michelle McMurray, ARNP they provide nonacute specialized medical examinations. Since opening, 40 children have been referred for specialized medical services and 20 children have received examinations on-site. Not only are children receiving this essential service locally, medical providers at the CAC are able to have ongoing communication with the multidisciplinary team thereby creating better outcomes for child victims served at the CAC.

### **On-Site Behavioral Health Services**

A 2019 Study of Behavioral Health for Childhood Trauma Recovery in NH showed significant gaps in services available for children who were victims of child abuse and neglect. Barriers included; distance, long wait lists, and a lack of providers. This prevented children from accessing essential behavioral health services needed to assess and treat the negative effects of childhood trauma.

In 2020 to increase access to this essential service, GSCA hired Andrew Wolff, LMFT to provide Behavioral Health Services. The expanded clinical service began in April of 2020. To date 33 children have received assessment and/or treatment by Andrew at the GLCAC. **The program has an 83% appointment attendance rate.** Andrew has also provided 164 treatment sessions with children at the GLCAC or through tele-mental health due to Covid-19.



### how GSCA and nh's network of CACs responded

- Educators are the number one reporters of child abuse and neglect in NH. GSCA and NH CACs needed to be innovative and resourceful in responding to children during social isolation and lack of in-person interactions. The Network of CACs worked together with law enforcement in the event local school administrators needed to conduct well-being checks on children deemed truant. There were so many challenges on children and caregivers during this time. Not engaging in their learning requirements was a red flag a child may need help.
- GSCA worked alongside leadership from DCYF, CASA, DHHS, The Office of Child Advocate and other child facing partners each week to compare data and discuss how the child protection system in NH can reach children in need during this time.

During the first week of the COVID-19 shut down, NH DHHS
 Conted that the Department of Children, Youth and Families
 (DCYF) Central Intake office experienced a 50% drop in reports of suspicions of child abuse and neglect. During this same time
 GSCA saw a significant drop in CAC referrals from law enforcement and DCYF. This was not due to a decline in child abuse.

It was the result of a decline of personal interaction between children and those adults most likely to report concerns (teachers, medical/mental health providers and other child facing professionals) to responsible authorities.

 In order to meet the needs of child victims and our multidisciplinary partners, while maintaining the health and safety of staff, children and caregivers, ALL 11 Child Advocacy Centers remained open, delivering in-person forensic interviews and family support services.

### An innovative response to an unprecedented event

focused mental health assessments and treatment virtually during the shut down and continues to be used for children in quarantine or those who live a great distance from GLCAC. In response to the COVID 19 shut down, the Greater Lakes Child Advocacy Center Mental Health Clinician, Andrew Wolff, developed a tele-mental health program which allowed children to receive trauma



KNOW & TELL<sup>™</sup> is a public responsibility program, to educate ALL ADULTS to KNOW the signs of abuse and TELL responsible authorities when they recognize a child needs help. Expert trainers provide interactive and dynamic workshops across NH on how to create a safe community where all adults understand their role as a mandated reporter of child abuse.

- 92% believe the training increased their knowledge of child abuse and neglect
- 96% believe instructors demonstrated expert knowledge
- 92% would recommend this training to others

### **KNOW & TELL<sup>™</sup> Peer-to-Peer Ambassadorship:**

The KNOW & TELL<sup>™</sup> Peer-to-Peer Ambassadorship Program was developed in May 2020 in response to many New Hampshire high schools reaching out to GSCA about KNOW & TELL<sup>™</sup> education for students. There was an interest in providing high school students with child abuse intervention education; especially for those students looking into child facing professions such as education, healthcare, social work and law enforcement. In 2020 a small group of students were identified to begin this work by developing the group's mission – "to EDUCATE peers, to INFORM communities, and PROTECT youth by redefining the culture and stigma of child abuse and neglect. These New Hampshire high school students are empowering their peers to BE THE DIFFERENCE for children experiencing abuse and/or neglect through teen lead development of educational materials and media.

The KNOW & TELL<sup>™</sup> Peer-to-Peer Ambassadors have dedicated countless hours developing new resources and educational tools for their peers including:

- Public Service Announcements
- KNOW & TELL<sup>™</sup> Aware Education Presentations
- Social media content
- Teen Body Safety Brochure
