

At the Granite State Children's Alliance, we believe safeguarding children is everyone's responsibility.

For more than two decades, we've played an integral part in developing child protection services, establishing **Child Advocacy Centers (CACs)**, and promoting **justice, healing, and hope** for tens of thousands of children impacted by abuse or neglect.

As the sole nonprofit coordinating with state and local law enforcement and NH's Division of Children, Youth and Families (DCYF), we operate four CACs in Hillsborough, Belknap and Cheshire counties and support the statewide network of centers with training, education, and resources.

Partnering with multiple organizations to provide a collaborative response to child abuse investigations, CACs provide a compassionate, neutral, victim-centric environment that reduces trauma for child victims. They offer forensic interviews, family advocacy, crisis intervention, and behavioral health therapy to child victims and their non-offending caregivers—all free of charge.

Child abuse inflicts deep and enduring wounds, but with timely intervention, support, and counseling, children can learn to cope and heal. Together with our dedicated staff, volunteers, supporters, and partners, we amplify children's voices.

child victims in NH participated in a forensic interview.

1,069

77%

were referred for trauma-informed behavioral health services.

944

68%

were referred to specialized medical providers.

CAC staff and partners had **4,782** follow-up contacts with caregivers to ensure they were able to access services.
